## **Light Therapy**

Professional light therapy innovation.

Light therapy is process in which a specific wavelength of light is projected onto the skin. The light causes chemical reactions in the target area, which excite cells to increase cellular performance, and could be useful for treat skin aging, rejuvenate skin, eliminate acne and skin spots. The key to light therapy is the wavelength of light, as different colours (wavelengths) produce different chemical reactions within the cells increased cellular activity in specific cells [1].

Originally discovered by NASA about 40 years ago to stimulate plant growth [2]. Red Light Therapy was also found to encourage cell repair and healing of injuries incurred by astronauts while in space. Even in a zero gravity environment, where cell growth is normally very slow, this red light energy was shown to stimulate the metabolism in muscle and bone as well as skin and subcutaneous tissue.

Recently, Quadra Medical introduced a new treatments which rely on the therapeutic effects of light at wave-lengths of visible light. Light therapy has shown strong efficacy for the treatment of wrinkles, sun damage, uneven skin tone, rosacea and inflammatory acne, because have the ability to increase energy inside cells which helps to speed up the healing process [3-7].

## Red light therapy (633nm)

Improving skin quality.


Red light (wavelength of 633nm) is able to penetrate the skin to a depth of 8 – 10mm. This penetration triggers the body to make collagen and elastin, and to generate new capillaries. The result of more collagen and elastin is firmer, tighter-looking skin, and the result of new capillaries is more circulation, which increases wound-healing and scar tissue reducing benefits. The complete action of the Red Light are:

## How long last the results?

However the following is a guideline for the frequency of exposure and corresponding expected results both for 42 Collagen BodyWave and 42 Whitening BodyWave:



#### AIM OF THE STUDY

The aim of this study is to evaluate the **anti - wrinkle** and **anti - ageing** efficacy of a specific aesthetic total body treatment by vertical equipment **42 COLLAGEN BODYWAVE**. In order to reach this goal the following skin parameters were measured:

- Skin moisturizing;
- Skin elasticity;
- Skin profilometry;
- Digital photo;
- Clinical evaluation

#### **METHOD DESCRIPTION**

The study is performed as follows:


- enrolment of 20 female subjects aged between 40 and 60 years who were divided into two experimental groups:
  - GROUP A 10 subjects who used 42 COLLAGEN BODYWAVE
  - GROUP B 10 subjects who used 42 COLLAGEN BODYWAVE in association with daily application of VITA SKIN BOOSTER ELIXIR e VITA SKIN BOOSTER CREAM;
- Evaluation of the treatment efficacy using the vertical equipment 42 COLLAGEN BODYWAVE by red light (λ= 633nm). The treatment includes 3 sessions of 15' each during 8 weeks;
- Evaluation of the clinical/instrumental parameters after 4 and 8 weeks of treatment. The
  monitored area is: face skin.


#### RESULT OF CLINICAL/INSTRUMENTAL PARAMETERS






The charts below, illustrate the variation of clinical/instrumental parameters in 3 different time, before the treatment (T0), after 4 weeks (T4) and at the end (T8). Respect the start condition all the parameters show a *positive variation highly significant* express by 3 stars, that are the maximum possible result.












#### SUBJECTS EVALUATION RESULT


The final satisfaction of the all subject at the end of the treatments express in terms of judgement a very good value:

#### **VISIBLE RESULT**



#### As you can note the skin appears more lifted and the wrinkles attenuated.


